President requested negative votes and abstentions by show of hands. There were none. All votes were recorded as roll call votes - Yes.

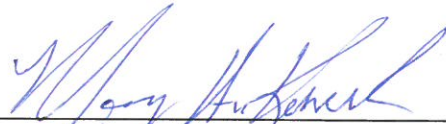
