The students of the Laurel School District spent approximately 1/3 of the school year on an impromptu cyber platform as a result of the disruption of traditional educational services. Due to this disruption, the Laurel SD is going to complete benchmark and diagnostic testing on all students k-8. We are going to have data on student progress relative to grade level and performance level. Based upon those levels, students will have intervention designed and implemented by an instructional support team led by a new position, a full-time instructional support teacher.

Please explain the LEA's proposed timeline for providing services and assistance to students and staff in both public and nonpublic schools. (3000 characters max)

At the beginning of the school year, students in grades k-8 will take diagnostic and benchmark testing in ELA & math. Students will then be placed in intervention groups. These intervention groups will be by performance and ability level. The services provided to students and staff in both public and nonpublic schools will be used for salaries and benefits. The Laurel SD will be creating a new position to address these deficiencies. The nonpublic schools will receive their apportioned share for salaries as well in hopes that they can expand their programming.

The Laurel School District has a developed a blended model of instruction to include a virtual component harnessing many Google Suite tools. The Laurel School District is also capable of providing a one-to-one learning environment should the need arise and schools close for the pandemic. The plan would be to utilize these technologies to support our interventions related to grade level and individual skill deficits. We would be able to not only continue with established classes, but

At the beginning of the year, targeting the first two weeks of school, students within the Laurel SD are going to complete benchmark and diagnostic testing on all students k-8. We are going to have data on student progress relative to grade level and performance level. Based upon those levels, students will have intervention designed and implemented by an instructional support team led by a new position, a full-time instructional support teacher.

Please describe the LEA(s) proposed procedures for evaluating local COVID-19 impacts in relation to education programming and delivery. (3000 characters max)

Areas of emphasis should include:

- Documenting learning loss associated with extended school closure;
- Outlining the development of local continuity of education plans over the course of emergency response efforts; and
- Detailing supports for vulnerable student populations and families.

The Laurel School District lost approximately 1/3 of the school year. The district had to transform its instructional practices to a virtual platform in approximately a week's time. Although, the students and staff nobly attempted to finish the school year. The administration and a representative group of teachers developed the local continuity plan as well as our response efforts to the pandemic. The last 60 days were not as effective as the first 120. The district is anticipating deficits in achievement as measured by beginning of the year bench marking and diagnostic testing. The most vulnerable student populations and families were supported by our pupil personnel department as well as local community supports like Project HOPE and a community food basket. For any student with an IEP and/or 504 accommodations, modifications and/or specially designed instruction was provided, to the maximum extent possible, to the student as outlined in their document to best meet their educational needs. Case managers, instructional aides, related service personnel, and regular education teachers worked together to ensure students were receiving planned instruction and FAPE. Students were working in a variety of mediums to ensure access to curriculum. A web based platform was used and the student should use the general education and/or the special education teacher's platform to access curriculum. Related service personnel worked with students through these web based platforms to provide services. Special education teachers had daily office hours and check their email twice a day. They contacted parents weekly. Progress monitoring on IEP goals will continue. Additionally, every Friday the administration worked with the local bread basket to feed the hungry amongst our population. Special Education and Gifted IEP meetings will be held - IEP Meetings will continue or may be rescheduled as we work through the process of holding the meetings online. IEP, ER and RR documents will be sent to parents prior to the meeting via email with parental permission. The Pennsylvania Bureau of Special Education has NOT waived Special Education Timelines. Therefore, currently scheduled IEP meetings will continue or be rescheduled via conference call and special education student evaluations will continue as planned. During the closure, the Special Education Department will contact those families waiting on student evaluations and teachers will coordinate IEP

meetings. Meetings will be held online or by phone conference. If a student is on timeline to be evaluated, the school psychologist will reach out to families.

These strategies may entail the establishment, scale-up, refinement, or evaluation of remote learning, as well as strategies for school-based teaching and learning responsive to conditions related to the pandemic. The Laurel School District will use the identification of academic deficiencies and targeting those skills gaps as a guide for local investment of CARES funding. We intend to immediately create a full-time IST teacher to respond to expected grade level skill deficits grades k-6. The long-range goal of the position is to target at-risk learners, develop strategies to address skill deficits and over the course of time (several years) return them to satisfactory levels of proficiency. This will be a school-based strategy for teaching and learning that is responsive to the expected gaps in achievement related to the pandemic. This position and associated school program will enhance and expand services to support achievement in ELA, math, and science, The design of the implementation of the new position will compliment the Title I instruction grades k-2, and address needs 3-6. It is the intent of the district to continue the programming beyond the delivery of the one-time CARES funds.

Please describe specific plans, measures, and longer-term evaluative strategies concerning student learning gaps - as well as opportunity to learn factors - stemming from COVID-19. (3000 characters max)

The plan will be evaluated through several data points (in-house diagnostic and bench marking data, long-term evaluation of grade level achievement as measured by PSSA results, cohort achievement as measured by the achievement of the same students through multiple grade levels). The program should identify grade level and skill gaps deficits. The instruction should be related to the identified deficits. Periodic bench marking should demonstrate progress on identified deficits. Grade level achievement and cohort achievement as measured by the PSSA tests should grow over the course of the next 3 years.
